- The purpose of Internal Audit is that the preparations as per "Risk Based Internal Audit Directive 2079 issued by Beema Samiti based the statements of OICL, Kathmandu, Nepal for the 2079-80.
- It is the sole responsibility of the deployed Internal Audit personnel to execute the assigned work perfectly and accurately as per the Regulator Requirement
- The OICL shall have the rights to remove any deployed Internal Audit personnel from the duty who is considered to be undesirable.
- The contractor shall issue identity card/identity documents of the employees who are deployed to execute the work.
- 5. The Internal Auditor shall not subcontract the assigned work to any other agencies.
- The OICL shall comply with and fulfill the recommendations (if any), if deemed necessary by the OICL, made in writing by the Contractor in connection with the performance of the services.
- If required amendment to the contract shall be effected from time to time in accordance to Government notifications or otherwise on mutual consent.
- 8. The contractor shall raise the invoice/Bill after completion of the work.
- All the payments to the contractor by the OICL shall be made through IPS/Bank transfer only with applicable TDS in accordance with the Govt. of Nepal guidelines from time to time.
- 10. The contractor shall execute the assigned work as per the schedule and if the same have not been executed up to the expected level, warning notice shall be issued in this regard. If the situation continues still, penalty will be imposed at the rate of 1% of the contract value per month.
