- 1. The purpose of appointing statutory Auditor is to conduct Statutory and Tax audit of our Nepal Operations for the Financial Year 2024-2025 and Nepal Financial year 2081-2082 BS as per Regulator requirement of India and Nepal
- 2. It is the sole responsibility of the appointed Statutory Auditor to execute the assigned work perfectly and accurately as per the Regulator Requirement
- 3. The OICL shall have the rights to remove any appointed Statutory Auditor personnel from the duty who is considered to be undesirable.
- 4. The contractor shall issue identity card/identity documents of the employees who are deployed to execute the work.
- 5. The appointed Statutory Auditor shall not subcontract the assigned work.
- 6. The OICL shall comply with and fulfill the recommendations (if any), if deemed necessary by the OICL, made in writing by the Contractor in connection with the performance of the services.
- 7. If required amendment to the contract shall be affected from time to time in accordance with Government notifications or otherwise upon mutual consent.
- 8. The contractor shall raise the invoice/Bill after completion of the work
